STAFF REPORTS

The Staff Reports were discussed.

Chad Clevenger explained the Park Art in Century Bark. It is a 14' tall flower with two bees. It is made from recycled playground pieces. Fabrication was done in house on inclement weather days. Kyle Uptegrove suggested that a plaque be installed explaining that recycled playground pieces were used and who was involved.

Youth recreational spring soccer has 177 participants up from 145 in the spring of 2021; youth intro to competitive soccer has 63 participants up from 15 in the spring of 2021; and youth volleyball has 56 participants. Youth volleyball was not offered in the Spring of 2021 because of Covid and no access to the school gyms. Spring youth recreation is off to a good start!

Women's volleyball has 8 teams this spring.

Jake Simmons shared information that he had researched regarding the property at the Airport. Jake will discuss it further when Councilman Stephen Spear is in attendance.

NEW BUSINESS

Nate Williams updated the Board on the City of Excelsior Springs Personnel Policy Revisions as adopted by the City Council on March 7, 2022. As an incentive, all full time staff and part time staff working 500 hours in a calendar year, will receive free membership to the Community Center. This will start on April 1, 2022.

Staff is building rapport with youth. Empowering employees to deal with issues. Adult usage has increased in the evenings.
